4. For partnership firms, if any member is unable to attend the verification, an authorization letter to the other member(s) with valid reason(s) must be submitted. For proprietary firm, the proprietor must appear in person for verification.
5. If the concerned person(s) of a firm cannot attend for verification on the specified date, he/she/they must report on the next working day for verification. However, he/she/they will be called for verification of documents only after completion of verification of applications scheduled for the day. If the concerned members do not attend for verification even on the next day, it will be presumed that they are not interested for registration anymore and will not be entertained until and unless proper justification for absence is shown.
6. For certain categories, the number of selected firms is more than number of seats. (This is due to similar marks scored by the firms). In case number of firms having proper documents is found to be more than actual number of seats, draw of lots will be held to select the firm for registration.
