Hiring of “Consultant Geologist-Static Modeller for a period of 2 years, extendable by another 6 months”.

1. Introduction:

OIL INDIA LIMITED (OIL), a Government of India “NAVARATNA” Category Enterprise, engaged in the business of Exploration, Production & Transportation of Crude Oil and Natural Gas and Production of LPG in India with participating interest in Oil & Gas sector in various overseas projects intends to hire above Service. Expression of interest (EOI) is invited from individuals having requisite experience, capability and specialization in carrying out the below mentioned assignments.

2. Job Description:

The work involves carrying out generating geological models using PETREL software. Candidate shall be involved in integrating petrophysics/well-logs with geophysical, geological, engineering studies during various phases of oil and gas exploration and production.

3. Duration of assignment:

2 years, extendable by 6 months. However, OIL will reserve the right to terminate the contract with a notice period of one month if the performance of the Consultant is not satisfactory or the job is likely to be completed before 2 years.

Consultant has to work in FHQ, Duliajan as per normal working hours of OIL/ as instructed. The Consultant has to arrange his own Lodging & Food, Conveyance during his/her stay in FHQ, Duliajan. OIL will not provide accommodation, food, conveyance etc.

4. Qualification Criteria:

Consultant (Geologist-Static Modeller) : 1 (One) no.

Essential Qualification : M. Sc., (Geology) /M.Tech (Applied Geology) from any recognized University.

Experience

: Minimum 10 years with expertise in handling PETREL software for building of Static model. The Consultant should have expertise on handling PETREL software (Version 2013 onwards). Period in this regard shall be reckoned prior to the closing date of the EOI.

Documentary evidence in regards to the above experience is required to be submitted along with the EOI response. Consultant may submit documentary evidences like experience certificate issued by the Organization, payment certificate, order/contract copy & completion certificate and any other documents acceptable to OIL.

- a) Candidate should be able to carry out detail geological evaluation, interpretation, stratigraphic correlation, mapping, structural cross-section, by integrating and collaborating available geological data (well-logs, core data and image log data) and geophysical data including seismic, VSP data and petrophysical data in Clastic Reservoir. Candidate should have knowledge on conceptual geological model, reservoir architecture, drive mechanism & heterogeneity and hydrocarbon distribution. The Candidate should be conversant on operating PETREL software for building geocellular model incorporating the conceptual geological model starting from Seismic. The candidate(s) should have experience of at least 3(three) Field Development studies involving drilling and completion of horizontal wells as on EOI closing date..
- b) Candidate should have good knowledge of work functionality in oil and gas sector.

5. Leave: The selected candidate(s) shall be entitled for 15 days paid leave every six months which can be availed to a maximum of 5 days at a time.
