The Despatch Station price of domestic bidder (inclusive of customs duty on imported raw material and components etc. and applicable terminal excise duty on the finished products and Sales Tax) excluding inland transportation to destination, entry tax/octroi and Insurance charges and CIF Landed price of foreign bidders [with customs duty (on total of CIF Value plus landing charges @1% of CIF Value) as applicable on the bid closing date] excluding inland transit insurance, entry tax/octroi and inland transportation to destination, will be compared. However, for contracts for supply cum installation/erection/site assembly, or turnkey projects where bidder's responsibility includes inland transportation, the evaluation will be inclusive of inland transportation.
