AMENDMENT NO. 1 DATED 20.03.2017
TO TENDER NO SSG3670P17/03

1.0 This Amendment no. 1 dated 20.03.2017 to tender no. SSG3670P17/03 for Procurement of **2.1/8" Through Tubing Deep Penetration Perforation Charges & Accessories** is issued to incorporate the following changes to the tender instead of the existing:

- 1.1 To **amend** clause no. 4(b) of Technical BEC/BRC as under:
The bidder must have sold the quoted item(s) to at least 01 E&P company/Logging service provider in last 05 (Five) years. At least 01 (one) of such orders successfully executed by the bidder in last 05 (five) years must be for minimum 50% of the estimated value of this tender (**i.e. Rs. 1,13,10,358.00 or equivalent.**)
- 1.2 To **amend** clause no. 4(c) of Technical BEC/BRC as under:
If the Bidder has supplied similar items to OIL INDIA LIMITED (OIL) during last 5 (five) years preceding original bid closing date of the tender either by themselves or through their sole selling agents/distributors/dealers/supply house and the past performance has been satisfactory, the bidder need not be required to submit documentary evidences as called for vide para 4(a) & 4(b) above. However, they must indicate the Purchase Order number and date against which those similar items were supplied to OIL by them in the past.
- 1.3 To **include** the following Note to Technical BEC/BRC:
Technical BEC/BRC clause no. 5(a) is mandatorily applicable to the Explosive items with serial nos. 10, 20 and 30 of this tender. For all other items in the Tender document, clause no. 5(a) is not mandatory.
- 1.4 To **delete** clause no. 5(c) of Technical BEC/BRC
- 1.5 To **amend** clause no. 5(d) of Technical BEC/BRC as under:
The bidder must have sold the quoted item(s) to at least 01 E&P company/Logging service provider in last 05 (Five) years. At least 01 (one) of such orders successfully executed by the bidder in last 05 (five) years must be for minimum 50% of the estimated value of this tender (**i.e. Rs. 1,13,10,358.00 or equivalent.**)
- 1.6 To **amend** clause no. 5(e) of Technical BEC/BRC as under:
If the Bidder has supplied similar items to OIL INDIA LIMITED (OIL) during last 5 (five) years preceding original bid closing date of the tender and the past performance has been satisfactory, the bidder need not be required to submit documentary evidences as called for vide para 5(d) above. However, they must

indicate the Purchase Order number and date against which those similar items were supplied to OIL by them in the past.

- 1.7 To extend the Bid Closing/Opening Date to : **05.04.2017**
To extend the Bid sale last date to : **29.03.2017**
- 2.0 All other terms and condition of the tender will remain unchanged.
