

CORRIGENDUM-3 TO TENDER NO : CGG 3751 P20
“Intelligent Pigging Survey (IPS) 355.6 mm (14”) OD
Noonmati-Barauni Oil Pipeline”

DUE TO VARIOUS RECENT DIRECTIVES FROM THE GOVERNMENT ON HOLDING OF MEETINGS IN ORDER TO REDUCE THE SPREAD OF NOVEL CORONAVIRUS (COVID-19), THE PREBID MEETING AGAINST TENDER NO CGG 3751 P20 HAS BEEN FURTHER POSTPONED TO 05.05.2020. WE ARE GOING TO HOLD THE MEETING THROUGH VIDEO CONFERENCING BY THE APP GOOGLE HANGOUTS. ALL PROSPECTIVE BIDDERS ARE ADVISED TO PROVIDE THEIR MOBILE NUMBERS WITH THEIR COMPANY’S NAME AND CONTACT PERSON’S NAME AT THE EARLIEST. PRE BID QUERIES ARE INVITED UPTO 15.30 HOURS OF 30.04.2020. NO QUERIES WILL BE ENTERTAINED BEYOND THE STATED TIME AND DATE. TECHNICAL BID CLOSING/OPENING DATE HAS BEEN FURTHER EXTENDED TO 15.05.2020 AT 11.00 & 14.00 HOURS RESPECTIVELY. ALL PROSPECTIVE BIDDERS ARE TO BE GUIDED ACCORDINGLY.

AS A SPECIAL CASE UNDER THE COVID-19 PANDEMIC SITUATION AND DECLARATION OF LOCK DOWN BY GOVT OF INDIA, *‘BIDDERS SHALL NOT BE REQUIRED TO SUBMIT THE REQUISITE ORIGINAL BID BOND ON OR BEFORE TECHNO-COMMERCIAL BID CLOSING DATE. HOWEVER BIDDERS SHALL POSITIVELY UPLOAD THE COPY OF BID BOND/SECURITY DEPOSIT WHILE SUBMITTING THEIR BID IN OIL’S E-TENDER PORTAL. BIDDERS TO CONFIRM THAT THEY WILL SUBMIT THE ORIGINAL BID BOND WITHIN 10 DAYS FROM THE DATE OF WITHDRAWN OF LOCKDOWN PERIOD BY GOVT OF INDIA.
