This Notification is issued to all concerned with reference to the aforesaid subject to notify the following:-

As per the zone of first preference of bid documents submitted against DCC4728L21, DCC4729L21 & DCC4730L21 for MMC 2021-2025, the number of 'contractors applied' exceeded the number of 'contractors required' in four zones, which are as follows:


After transfer of zone of preference, if the numbers of eligible bids against the above four zones still exceed Company's requirement, selection will be done through Draw of Lots.
