**Special Notes** : 1. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of receipt of the items at site which ever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.

2. The minimum FOB/FCA charges in case of partial order for reduced quantity/ items shall have to be indicated by the bidder. In case this is not indicated specifically, the charges quoted would be prorata calculated and the same will be binding on the bidder.

3. Bidders to note that Govt. of India under Micro, Small and Medium Enterprises Development (MSMED) Act 2006, has proclaimed the Public Procurement Policy, 2012 with effect from 1st April, 2012 in respect of procurement of goods and services, produced and provided by micro and small enterprises, by its Ministries, Departments and Public Sector Undertakings for promotion and development of Micro and Small Enterprises. A new Clause on

applicability of Public Procurement Policy for procurement of goods from Micro and Small Enterprises (MSE) in the tender is furnished vide Amendment to General Terms and Conditions for Global Tender (MM/GLOBAL/E-01/2005). Bidders are requested to take note of the same and to submit their offers accordingly wherever applicable.

4. Bidder shall be OEM or authorised dealer of OEM. Valid dealership certificate should be enclosed along with the bid or else the offer will be rejected.

5. Bidders to take note of clause no.10.1.3 which has been added in Section-C, special terms & conditions for Indian bidders of General Terms and Conditions for Global Tender (MM/GLOBAL/E-01/2005-July2012) regarding transportation of materials.

6. The General Terms & Conditions for Global Tenders (MM/GLOBAL/01/2005) has been amended and the amendment dated 25.04.2016 have been issued in this regard which is uploaded in OIL Website. Bidders to note the changes made to "The General Terms & Conditions for Global Tenders (MM/GLOBAL/012005)" and to submit their offers complying with the same.

7. Validity of the offers should be 90 days from the date of bid opening. Bids with lesser validity shall be rejected.

8. Quotation must be submitted in triplicate.

9. The items covered by this enquiry shall be used by Oil India Limited in the PEL/ML areas which are issued/renewed after 01/04/99 and hence Nil Customs Duty during import will be applicable for foreign bidders. Indigenous bidder shall be eligible for concessional rate of IGST against Essentiality Certificate wherever applicable as per Notification No.3/2017-Integrated Tax (Rate) dated 28th June, 2017.

10. In view of implementation of GST w.e.f. 01.07.2017, The General Terms & Conditions for Global Tender(MM/GLOBAL/01/2005) has been amended and the Addendum dated 21.08.2017 has been issued in this regard which is uploaded in OIL Website. Bidders to note the changes made to "The General Terms & Conditions for Global Tenders (MM/GLOBAL/01/2005)" and to submit their offers complying with the same.

11. Bidders to note that Ministry of Petroleum & Natural Gas, Government of India implemented PPLC Policy to provide Purchase Preference (linked with local content) by notification no. Ref. O-27011/44/2016-ONG-II/FP dtd.25.04.2017. A new Clause on applicability of Purchase Preference (linked with local content) policy in the tender is furnished vide addedndum dated 21.08.2017 to General Terms and Conditions for Global Tender (MM/GLOBAL/E-01/2005). Bidders are requested to take note of the same and to submit their offers accordingly wherever applicable.

12. Successful bidder shall be required to furnish a Performance Security equivalent to ten (10%) of total evaluated value of Order, which should remain valid throughout the period execution, including extension, if any. The successful bidder shall submit Performance Security within 30 days of award, failing which OIL reserves the right to cancel the order and forfeit their Bid Security. Bidders should undertake in their bids to submit Performance Security as stated above.

13. OIL reserves the right to inspect, test and if necessary reject any part/parts after delivery at site (including incomplete manuals, catalogues, etc.) in case of any fault on the part of the supplier.

14. To keep the unit fully operational, in case of failure of any item during the warranty period, it shall be the supplier's responsibility to arrange replacement/repairing at site at their cost including customs, freight, etc. within a period of maximum three (03) weeks from the date of

notification of such failure and warranty for such items shall be extended accordingly.

**15. TECHNICAL MANUAL AND CERTIFICATION FOR OPERATION AND MAINTENANCE OF THE UNIT:**

15.1 The following Manuals & Catalogues in printed form (in English) shall be supplied along with the unit in addition to the supply of the same in CD or DVD. Supply of the manuals/catalogues only in CD or DVD is not acceptable. Manuals/ Part Catalogues provided shall be Custom Illustrated for the particular unit and equipment only, not a general Composite Manual/Catalogue.

A. The bidder has to supply two (02) sets of operating, maintenance and spare parts manual for operation and maintenance of the unit showing all sub assemblies and entire requisite spare parts with Part No (Preferable OEM part).

B. Two (02) copies of all relevant test and quality control certificates of the manufacturing and testing of the unit functions and parameters shall be supplied.

C. All test certificates, test reports and other certificates shall be provided separately as a set in a compiled manner.

D. The bidder shall submit Cross Sectional Drawing showing major dimensions of the unit.

E. The bidder shall confirm that hydraulic testing will be carried out at 1.5 times working pressure of the tendered item and certificate will be submitted along with material supply.

**16. BID SUBMISSION & DOCUMENTATIONS:**

16.1 Bidder#s response to all NIT stipulations should clearly be defined maintaining the same sequence as in the Tender. Bidder shall furnish specific details/specifications of all major components, systems with Make & Model etc. Submission of technical leaflet/catalogue alone is not sufficient. General Response like- #As per NIT Specifications / Technical Leaflet#, #Noted# etc. or in any similar fashion is not encouraged. Quoting only the NIT stipulation without any confirmation of acceptance of the same and/or without any confirmation of offering the same is also not acceptable.

17. The bidder shall confirm that the followings shall be embossed permanently on the body of tool:

- a. OIL's purchase order no.
- b. Equipment serial number
- c. Manufacturer's name
- d. Rated working pressure

18. Delivery: Bidders are to quote their best delivery time. The delivery required against this tender is Eight (8) months for all the items from the date of issue of Letter of Credit (For Foreign Bidders & award of PO (For domestic bidder). No preference/ benefit / weightage shall be given for shorter delivery period.

**19. PACKING, PAINTING AND PROTECTION:**

Packing shall be sufficiently robust to withstand rough handling during shipment and up country journey. All items shall have their respective identification letters or numbers painted on them and they shall be suitably packed to provide ease of handling and storage and maximum protection during transport and storage period. Crates and boxes shall have a list of items contained therein secured to the exterior by piece of an enveloping piece tin sheet nailed to the wood. A duplicate list shall also be included inside, with the contents. Sling points shall be clearly

indicated on the crates.

20. The bidder shall furnish a list of recommended spares & components that may be required for regular operation and maintenance, overhauling etc. of the equipment complete with Part No, Unit price and annual consumption pattern of them. THE PRICE QUOTED FOR RECOMMENDED SPARES WILL NOT BE TAKEN IN TO ACCOUNT FOR BID EVALUTION.

21. The bidders must submit a written undertaking (along with the bid) that they would be able to supply all the requisite spares and consumables (including bought out items) for a minimum period of 5 (five) years from the date of issue of item suitability report.
