**CORRIGENDUM**

**Amendment No. 1 Dated 19.07.2018**

**Tender No. SJ18417P19**

This Amendment No. 1 dated 19.07.2018 to **Tender No. SJ18417P19 for Infrared Gas Sensor** is issued as under:

- A. Point no. 10 under Item description of Item no. 10 to be read as under in lieu of existing:

Area classification: Class I, Division 1 & Division 2, Group I, IIA, IIB, IIC and dust area Zones 21 and 22.

- B. The following clauses are added to the tender document:

1. The items & its accessories should be brand new, unused and of prime quality.
2. Quotation should be forwarded in a tabular form, enlisting the compliance and deviations of the technical specifications for ease in scrutiny.
3. Product catalogue / literature should be provided along with the offer.
4. Offers from bidders other than OEM must provide valid documentary evidence / authorization certificate from OEM.
5. The bidder must quote for the latest model and should indicate the year of launch of the offered model. Obsolete products will not be considered for evaluation.
6. The bidder must provide service and supply spares, if required for the quoted items for at least next 5 years. The bidder has to provide firm confirmation in this regard during submission of bid.
7. Guarantee / warranty certificate for the items and its accessories valid for at least 18 months from the date of dispatch or 12 months from the date of successful commissioning, whichever earlier should

be provided along with the material. The bidder has to confirm the same in writing during submission of bid.

8. Calibration certificate & data with traceability to National/International Standards for the items & accessories (applicable for whichever) should be provided along with the material. The bidder has to confirm the same in writing during submission of bid.

9. The bidder must quote for Intrinsically safe model of the items. Offer from bidder bidding for Non-Intrinsic safe model will not be accepted for technical evaluation.

10. The bidder should state the address of their service centre for their offered item along with the offer. Bids from bidders having their authorized service centre in India will only be considered for evaluation.

11. The items and its accessories will be inspected by OIL's Instrument Engineer at supplier works before dispatch and supplier has to inform OIL for inspection at least 15 days before the inspection date. During inspection, all the functions of the items should be demonstrated by the supplier to OIL's Instrument Engineer. The supplier must produce all the relevant documents of the items & accessories for inspection by OIL.

12. Packing must be adequate to avoid damages during transit.

13. Any manufacturing defects / transit damages observed after receipt of the materials must be replaced within a short period of time by the supplier at their own expenses.

14. Scope of commissioning work :

14.1 Vendor has to commission the instrument and a training / demonstration on the operation and maintenance of the IR gas sensor & its accessories at free of cost at site i.e. in our Gas Processing Complex at Dandewala (DND-GPC) must be provided. Note that DND-GPC is about 35 Kms away from our Guest House at Tanot (Tanot Village Complex) and the distance from Jaisalmer to TVC is 120 Kms.

14.2 Presently we have MX43 Controller, Wall-mounted version, 8 channels with RS485 digital output, with multilingual menus in FR, EN, GE, CN, RU user manual in english language. All the cabling cable glanding will be in Oii India's Scope, Engineering & Design for communication between detector and Controller will be in Vendor's scope

14.3 OIL will inform the party after immediately receive the materials at site and supplier has to inform OIL for the commissioning and training / demonstration at least 15 days before starting the job accordingly.

14.4 Accommodation, Fooding at TVC and Transportation from TVC to DND-GPC for 1 person may be provided during commissioning period by OIL.
