This Amendment No. 3 dated 09.12.2020 to **Tender No. SSH5240P21/05** is issued for the following:

- AA) To amend Bid Security / Earnest Money Deposit (EMD) and Performance Security clause of the tender as below in place of existing:
- i) **AMENDED BID SECURITY CLAUSE** - No Bid Security /Earnest Money Deposit (EMD) is required to be submitted against the e-tender. Instead of EMD /Bid Security, all the bidders shall be required to sign a “Bid securing declaration” accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the NIT/ Purchase order, they shall be suspended for the period of two (2) years. This suspension of two years shall be automatic without conducting any enquiry. Bidders shall submit “Bid Securing Declaration” as per enclosed PROFORMA-4 along with their Technical bids.
- ii) **AMENDED PERFORMANCE SECURITY CLAUSE** - Successful bidder shall be required to furnish a Performance Security equivalent to Three percent (3 %) of total evaluated value of Order within 30 days of receipt of LOI/notification of award/ placement of Purchase order.
- iii) a) Bid Closing Date & Time: **23.12.2020 at 11:00 (IST)**  
b) Technical Bid Opening Date & Time: **23.12.2020 at 14:00 (IST)**
- BB All other Terms & Conditions of the tender remain unchanged.
