**CORRIGENDUM DATED 21.11.2020 TO TENDER NO. CDC5574P21**

**Description of Service:** Construction of Bituminous Road from BGP#005 Well entrance to Lakhipathar - Digboi Main Road Tiniali by repairing WBM, laying 25mm thick SDBC and applying sealcoat including supply of all materials by the contractor except Cement . Total Length = 4.650 Kms.

This Corrigendum is issued to all concerned bidders of the subject tender to notify the following:

Clauses pertaining to UDIN and Undertaking (Annexure-VII to tender) have been revised in BEC BRC as under:

**Clause No. 2.1.2 (c) of BEC/ BRC:**

Considering the time required for preparation of Financial Statements, if the last date of preceding financial/accounting year falls within the preceding six months reckoned from the original bid closing date and the Financial Statements of the preceding financial / accounting year are not available with the bidder, then the financial turnover of the previous three financial/ accounting years excluding the preceding financial / accounting year will be considered. In such cases, the Net worth of the previous financial / accounting year excluding the preceding financial / accounting year will be considered. However, the bidder has to submit an affidavit / undertaking as per format prescribed in Annexure-VII, certifying that “the balance sheet / Financial Statements” for the financial year ..... (as the case may be) has actually not been audited so far.

Note to Clause No. 2.1.2 (c): As per GOI, Ministry of Finance, CBDT Notification ref no: 88/2020/F.No.370142/35/2020-TPL Dated: 29th October, 2020 the due date for Tax Audit for the FY 2019-20 for all the assesses referred to in clauses (a) and (aa) of Explanation 2 to sub-section (1) of the said section 139, stand extended to the 31st day of January, 2021.

As per the above notification, in absence of the financial statements for the FY 2019-20, Undertaking as per format prescribed in Annexure-VII shall be accepted against this tender. However, in case of non-submission of the Undertaking within the bid closing date and time, bid shall be rejected straightway and no further claim shall be entertained after the bid closing date.

**Clause No. 2.1.2 Note 1. of BEC/ BRC:**

Mention of UDIN (Unique Document Identification Number) is mandatory for all certificates, tax audit reports etc. issued by Chartered Accountant as per the notifications issued by the Institutes of Chartered Accountant of India (ICAI).

Certificates, tax audit reports etc. without mentioning of UDIN shall not be considered for evaluation and shall be summarily rejected. No further clarification or request from bidders shall be entertained thereafter in this regard.

The revised BEC/ BRC have been uploaded in the “Amendments” folder in E-Tender portal and relevant changes have been highlighted in yellow.

All others terms and conditions of the tender remain unchanged.
