#### **i) SECTION-I, Para 6.0 :**

This tender is invited under Single Stage Single Bid system. The original Bid Security shall be submitted by bidder in a sealed envelope & must drop in the Tender Box, placed at the office of Executive Director (E&D), Oil India Limited, 5<sup>th</sup> Floor, NBCC Centre, Plot No.2, Okhla Phase-I, New Delhi-110020 on or before 14:00Hrs on the Bid Closing date, failing which the bid shall be rejected outright. Tender No. & Bid Closing date & Name of bidder must be written on the envelope containing the Bid Security for proper identification.

#### **iii) SECTION-VII , (1) Bid Rejection Criteria, C - General Criteria, Para V :**
