1.0 The tender will be governed by “General Terms & Conditions for National Tender (National Competitive Bidding)” for e-Procurement as per Booklet No. MM/LOCAL/E-01/2005(For e-tenders).

4.0 Necessary Login ID & Password will be issued by OIL only after submitting the complete online registration by the Bidder. In the event of late registration/incomplete registration by Bidder, OIL INDIA LIMITED shall not be responsible for late allotment of User ID & Password and request for bid closing date extension on that plea shall not be entertained by Company.

5.0 Bidders to note that Govt. of India under Micro, Small and Medium Enterprises Development (MSMED) Act 2006, has proclaimed the Public Procurement Policy, 2012 with effect from 1st April, 2012 in respect of procurement of goods and services, produced and provided by micro and small enterprises, by its Ministries, Departments and Public Sector Undertakings for promotion and development of Micro and Small Enterprises. A new Clause on applicability of Public Procurement Policy for procurement of goods from Micro and Small Enterprises (MSE) in the tender is furnished vide Amendment to General Terms and Conditions for Global Tender (MM/GLOBAL/E-01/2005). Bidders are requested to take note of the same and to submit their offers accordingly.

5.1 For availing benefits of Purchase Preference under Public Procurement Policy, the interested MSE Bidders must ensure that they are the manufacturer of tendered item(s) and registered with the appropriate authority for the said item(s). The technical offer of such MSE Bidders must include a valid copy of relevant MSE Certificate issued by appropriate authority specifying the item as per tender. Purchase Preference of 15% (fifteen percent) shall be extended to the eligible MSE Bidder (i.e. Manufacturer of tendered goods for procurement) over non-MSE L1 Bidder and PO shall be awarded for full tender quantity on such MSE bidder, subject to matching their quoted rates/costs with non-MSE L1 Bidder.

**5.2 MSEs Units (manufacturers/Service Providers only and not their dealers/distributors) who are already registered with District Industry Centers or Khadi & Village Industries Commission or Khadi & Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts & Handloom or any other body specified by Ministry of MSME are exempted from payment of Bid Security (EMD) irrespective of their product category & capacity, subject to submission of valid MSME registration certificate issued by appropriate authority.**

5.3 Bids without EMD shall be rejected, if the technical offer does not include a valid copy of relevant MSE Certificate issued by appropriate authority. It is in the interest of such MSE Vendors to furnish a copy of complete certificate to the concerned tender handling officer of OIL at least seven (7) days prior to the scheduled Bid Closing Date of the tender. Late communication in this regard and request for bid closing date extension on that plea shall not be entertained by Company.

**6.0 Purchase Preference (Linked with Local Content) (PP-LC) is not applicable against this tender.**

- 7.0 Bidder seeking benefits of MSME and Purchase Preference Policy (Linked with Local Content) shall clearly indicate the same in the tender with proper documents as stipulated in the tender.
- 8.0 OIL INDIA LIMITED (OIL) has upgraded its E-tender Portal. As part of the new system, the intending bidder must have Encryption Certificate along with Digital Signature Certificate (DSC) of Class III [Organization]. **All the Bids must be Digitally Signed using “Class III” digital certificate (e-commerce application) with ‘Certificate Type: Organisation Certificate’ as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India. - 9.0 EMD must be paid either through online mode or submitted as Bank Guarantee/LC. No DD/Cheques/Cashier Cheque or any other mode will be acceptable.

- 13.0 Bidders are requested to examine all instructions, forms, terms and specifications in the tender. Failure to furnish all information required as per the tender or submission of offers not substantially responsive to the bid in every respect will be at the bidder’s risk and may result in rejection of its offer without seeking any clarifications.

- 14.0 Any deviation(s) from the tender specification should be clearly highlighted specifying justification in support of deviation.
- 15.0 Original Bid Closing Date shall be considered by OIL for evaluation of BRC Criteria in case of any extension of the original bid closing date.
- 16.0 Along with the technical bid, bidders must submit duly filled undertaking as per format provided vide **Annexure-FF** as undertaking towards submission of authentic information/documents.
- 17.0 The tender is invited under **SINGLE STAGE-COMPOSITE BID SYSTEM**. The bidder has to submit both the “TECHNO-COMMERCIAL UNPRICED BID” and “PRICED BID” through electronic form in the OIL’s e-Tender portal within the Bid Closing Date and Time stipulated in the e-Tender. The “Techno-commercial Unpriced Bid” shall contain all technical and commercial details except the prices which shall be kept blank. Details of prices as per Price Schedule to be uploaded as attachment in the Attachment Tab “Notes and Attachments”.

Any offer not complying with above submission procedure will be rejected as per Bid Rejection Criteria mentioned in the tender.

- 18.0 For the convenience of the qualified Bidders and to improve transparency, the rates/costs quoted by bidders against OIL’s e-tenders shall be available for online viewing by such Bidders whose price bids are opened by Company. A Bidder can view item-wise rates/costs of all other such peer bidders against the tender immediately after price bid opening, if the e-tender is floated by Company with PRICE CONDITION. In case the Price Bid is invited by Company through attachment form under “Notes & Attachments” (i.e., NO PRICE CONDITION), Bidder must upload their detailed Price-Bid as per the prescribed format under “Notes & Attachment”, in addition to filling up the “Total Bid Value” Tab taking into account the cost of all individual line items and other applicable charges like freight, tax, duties, levies etc.. Under NO PRICE Condition (i.e.

Price Bid in attachment form), the “Total Bid Value” as calculated & quoted by the Bidder shall only be shared amongst the eligible bidders and Company will not assume any responsibility whatsoever towards calculation errors/omissions therein, if any. Notwithstanding to sharing the “Total Bid Value” or the same is whether filled up by the Bidder or not, Company will evaluate the cost details to ascertain the inter-se-ranking of bidders strictly as per the unloaded attachment and Bid Evaluation Criteria only. - 21.0 Other terms and conditions of the tender shall be as per “General Terms & Conditions for National Tender (National Competitive Bidding)” for e-Procurement as per Booklet No. MM/LOCAL/E-01/2005(For e-tenders). However, if any of the clause of the Bid Rejection Criteria / Bid Evaluation Criteria (BEC / BRC) contradicts the clauses in the General Terms & Conditions of the tender and/or elsewhere, those mentioned in the BEC/BRC shall prevail.

**ANNEXURE – AA****TECHNICAL SPECIFICATION**

Supply of Brand New Diesel Engine Driven Truck with Double cabin (Seating arrangement in the cabin shall be for minimum six nos. of persons excluding driver) & High Side Deck with Hood Cover Load Body for PS7, Mechanical Maintenance as per specifications, fitment and accessories, terms & conditions etc. detailed hereunder.

**A. Technical Specification:**

The truck is to be supplied as per any of the following two options:

**OPTION-A:** Supply of Factory Built complete unit i.e. Factory Built Truck with Dual Cab & Load body unit.

**OPTION-B:** Supply of Truck with subsequently fabricated Dual Cab on Factory Built Truck with Cab & Load Body unit.

**NOTE:**

- (i) The term "FACTORY BUILT "means- Originally built/ fabricated in all respect at chassis manufacturers factory, ready for direct procurement as a composite single unit at showroom condition without requiring any subsequent additional fabrication job/ work/ fitment.
- (ii) If Factory Built Complete unit is available under production range of MAKE of truck being offered, bidder shall offer truck as per Option-A only.
- (iii) Model Name of the truck and the option (Option A or B above) under which the same is being offered shall clearly be indicated in the bid.

**(1) CHASSIS:**

Brand new chassis having following specifications:

**ENGINE:**

**Axle & Suspension** : Semi elliptical leaf Springs with shock absorbers.

**GVW (Kgs)** : 8500 (+/- 500 Kgs)

**DIMENSIONS** : CAB & LOAD BODY

OVERALL Length (Cab + Load body) = 5900 mm (+/- 200 mm)

CAB: Double Cabin with seating capacity for minimum six persons excluding driver

DUAL CAB Length = 2400 mm (+/- 100 mm)

DUAL CAB Width = 2100 mm (+/- 100 mm)

**LOAD BODY:** High Side Deck with Hood Cover(Roof) Load Body with a suitable door in the rear side for loading /unloading of materials.

Load Body Length = 3400 mm (+/- 100 mm)

Load Body Width = 2100 mm (+/- 100 mm)

Load Body Height = 1650 mm (+/- 100 mm) from loading floor

**(2) LOAD BODY, CABIN & OTHER FEATURES:****(i) LOAD BODY:**

The Load Body shall be original one that comes along with Factory Built Truck with Dual Cab & High Side Deck with Hood Cover (Roof) Load Body unit (Option A) or Factory Built Truck with load body & subsequently constructed Dual Cab at reputed Bodybuilding workshop having the specification as under. However, in case of supply under option B, bidder as required shall cut & reduce the length of the original Load Body to accommodate the Dual Cab.

- (a) Construction: All Steel Structure Construction
- (b) Mounting on Chassis: Through heavy duty U-bolt.
- (c) Flooring: Made of chequered plate or corrugated sheet of adequate thickness.
- (d) Rear Overhang (ROH): As per original design. No overhang of Load Body beyond chassis. Extension of chassis to accommodate Load Body is not acceptable.
- (e) High Fixed Side Deck with Hood Cover (i.e. with roof) with a suitable door in the rear side for loading /unloading of materials.

**(ii) CABIN:**

Dual Cab driver's cabin preferably factory built (OPTION-A) i.e. originally built/ fabricated in all respect at chassis manufacturer's factory that comes along with the chassis & without requiring any subsequent additional fabrication, fitment job on it or as per OPTION B.

It shall have the following features:

- (a) All steel structure construction same as that of the original cabin
- (b) Seating capacity: Min. 6 (Six) persons excluding driver.
- (c) 1(one) Deluxe/comfortable Seat for 2 (two) passengers at front & parallel to driver's seat.
- (d) Second row Deluxe/ comfortable Seat for 4 (four) passengers with sufficient legroom.
- (e) In addition, all standard windows, 1 (one) sliding glass window with wire-mesh guard from outside at rear; Non-splinter/ toughened glass- panes lockable from inside for windows.
- (f) Minimum 3 mm thick chequered Plate flooring for the extended portion of the floor or as per manufacturer's design in case of supply under Option- B.
- (g) Minimum 3(three) Nos. lockable door with glass window for driver & passengers with proper footsteps.
- (h) Provision should be made for a small ladder on the rear side of the vehicle for easy movement/climbing to the load body of the pickup truck and a small handle as support while climbing should be fabricated.
- (i) A bar in front of dual cab seats to be fabricated as support to the passengers seated on the dual cab.
- (j) A outside handle beside the door of the dual cab should be fabricated to help passengers get up on the dual cabin side easily.

**(iii) OTHER FEATURES:**

- (a) Well-Covered/clamped Battery Box with locking facility located outside the cabin.
- (b) Cabin Ceiling with good quality heat resistant material inside.
- (c) Exterior painting: Imperial crimson (not Cherry) color with quality finish.
- (d) Interior painting: as per standard (light shade)
- (e) Rust proof painting for Chassis & undercarriage
- (f) Suitable sliding window at the rear mid of the cabin with wire mesh guard from outside.
- (g) Lockable fuel tank, standard Tool Kit, Wheel wrench, Mud flaps, foot mat, fog light, Reverse Gear Alarm, suitable storage box under the rear seat etc.
- (h) Suitable towing hook(s), mounting arrangement for spare wheel
- (i) Rear View Mirror- 2 Nos. Exterior & 1 No. Interior.
- (j) Jack with handle.
- (k) Spare Wheel.
- (l) First Aid Box.
- (m) Portable Fire Extinguisher.
- (n) Speed Limiting Device (SLD): To be provided with valid certification as per Indian Motor Vehicle Rules as applicable in the state of Assam (India).

- (o) GPS: To be provided with valid certification as per Indian Motor Vehicle Rules as applicable in the state of Assam (India).
- (p) Vehicle should be fitted with all standard accessories & fittings like lightings & electrical fittings, Head Lamps, Parking Lamps, Direction Indicator Lamps, Tail Lamps, Marker Lamps (Top, Side and Repeater), Stop Lamp, Windscreen Wipers, Hazard Light Flashers, Rearview Mirrors at both sides, Retro Reflective Tape, Warning Triangles, Horn etc. and any other fittings & accessories required as per Indian Motor Vehicle Act, 1988 and Central Motor Vehicle Rules, 1989.
- (q) Vehicle should be fitted with all standard gauges such as speedometer, odometer, air pressure gauges, charging system gauge, engine oil pressure gauge, engine temperature gauge, fuel gauge, etc. and any other items with warning displays (as per OEM) required as per Indian Motor Vehicle Act, 1988 and Central Motor Vehicle Rules, 1989 preferably in MKS system.
- (r) Vehicle must comply with Indian Motor Vehicle Act, 1988 and Central Motor Vehicle Rules, 1989.
- (s) Detailed dimensional drawing of the Truck along with material construction of the Dual cab, Load body, structure etc. should be submitted along with the bid by the bidder(s).

**Note:** Also, the bidder shall have to submit final dimensional drawings of the Dual cab, Load body, structure etc. with detailed material construction of the Dual cab, Load body, structure etc. within 30(thirty) days from the date of OIL's purchase order before manufacturing the Truck. The same should be prepared based on order specification & OIL's requirement and shall be duly approved by OIL.

**B. DOCUMENTATION:**

- (i) The following documents/ literatures are to be submitted along with the bid:
  - (a) All specifications, as desired, as well as MODEL NAME & MAKE of the offered truck shall clearly be mentioned in the bid along with a Technical Leaflet, to support the specifications provided in the bid.
  - (b) A Dimensional drawing, showing among others - overhang, sitting arrangement, seat size & legroom, along with the material description of fabrication.
- (ii) The following documents/ literatures are to be submitted along with the supply -
  - (a) Temporary Registration, Original Sale Letter in Form 21 & 22/22(A), Original invoice, etc. as per MV act.
  - (b) Temporary Registration of the Truck shall be made in the name of OIL INDIA LIMITED. The temporary registration period should be w.e.f the date of handing over the complete Dual Cab Vehicle to Oil India Limited
  - (c) A valid certification against SLD, GPS and any other documents required as per Indian Motor Vehicle Act, 1988 and Central Motor Vehicle Rules, 1989 as applicable in the state of West Bengal.
  - (d) 3 (three) sets of Spare Parts Catalogue, Workshop & Service Manual, Operator's Manual.

**C. INSPECTION & DELIVERY, GENERAL TERMS & CONDITIONS:**

- (i) The supplier (Successful bidder) shall facilitate inspection for the truck by OIL's engineer as under and intimation shall be sent to OIL accordingly:

In case of supply under Option-A: Inspection at supplier or delivery point dealer/distributor's showroom/ premises.

In case of supply under Option-B: Inspection at supplier's works/authorized works/showroom/ premises in Assam after completion or during fabrication. OIL, at its discretion, may inspect the truck prior to starting the fabrication job in addition to above.

Supplier shall affect dispatch of the truck to OIL only on receipt of OIL's acceptance/ dispatch advice and delivery shall be up to Oil India Limited, Pump Station no. 7, Madarihah, West Bengal.

- (ii) Notwithstanding the Guarantee/ Warranty clause(s) mentioned elsewhere in the NIT, complete Truck unit shall be under guarantee/warranty by the supplier for a minimum period of 1 (one) year from the date of successful delivery of the vehicle at site. Even after delivery of the truck, if any manufacturing /fabrication defect is found out at any stage, the delivery will not be treated as complete and the supplier has to attend it free of cost to our satisfaction.



**BID REJECTION CRITERIA/ BID EVALUATION CRITERIA****I. BID REJECTION CRITERIA (BRC):**

The bids must conform to the specifications, terms and conditions given in the tender document. Bids shall be rejected in case the items offered do not conform to the required minimum/ maximum parameters stipulated in the technical specifications and to the respective international /national standards wherever stipulated.

Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the offer/ offers will be considered as non-responsive and is/are liable to be rejected, if the following conditions are not fulfilled:

**(A) TECHNICAL**

1.0 **For OPTION-A:** In case bidder submits their offer to supply Factory Built complete unit i.e. Factory Built Truck with Dual Cab & Load body unit, then, the bidder shall be Chassis Manufacturer or their Authorized Dealer/Distributor of the Chassis Manufacturer. In case the bidder is an Authorized Dealer/Distributor, they must submit Dealership/Distributorship Certificate from the Original Manufacturer which shall be valid till completion tenure of order.

2.0 **For OPTION-B:** In case bidder submits their offer to supply Truck with subsequently fabricated Dual Cab on Factory Built Truck with Cab & Load Body unit, then, the bidder shall be a Chassis Manufacturer or their Authorized Dealer/Distributor having experience of fabrication (*i.e. experience of fabrication by bidder or by the works/ party where fabrication job shall be carried out*) of at least 3 (three) numbers of Dual Cab during last 7(seven) years to be reckoned from the original bid closing date. In case the bidder is an Authorized Dealer/Distributor, they must submit Dealership/Distributorship Certificate from the Original Manufacturer which shall be valid till completion tenure of order.

OR

The bidder shall be a Cab/Body Builder having experience of fabrication of at least 3 (three) numbers of Dual Cab during last 7 (seven) years to be reckoned from the original bid closing date.
