1. Introduction

Oil India Limited (OIL) invites **Expression of Interest (EOI)** from interested and reputed domestic Service Providers with relevant experience and expertise for carrying out various works associated with the acquisition of land for OIL’s drilling locations, projects, pipe-tracks, etc. in the State of Assam and Arunachal Pradesh.

Note: Service Providers(s) having their own in-house services are qualified to participate. Any submission through agents or sub-contractors or intermediates will not be acceptable.

2. Brief Description and Service Required

OIL has been acquiring land for its various drilling locations, projects, pipe-tracks, etc. through its Bipartite Settlement mode (outright procurement: willing seller and willing buyer), under provisions of AL&RR, 1886, Land Acquisition Act, 2013 and under P&MP Act, 1962 for acquisition of ROU, etc. It is intended to hire services of Service Provider(s) for assisting OIL in acquiring land through above various procedures / processes including services for allied civil survey jobs, permissions for various NH / PWD / Railway / River crossings, Forest Clearances, providing assistance in matters like pursuing with District & State Authorities for early approval of Land Sale Permission (NOC), preparing/collecting requisite documents as well as assist in mutation of acquired land in Company’s name.

3. Broad Scope of work

- a. Detail Engineering & Cadastral Survey towards outright procurement of land for OIL’s drilling locations, projects, pipe-tracks, etc. and towards acquiring ROU for pipe-tracks under P&MP Act, 1962.
- b. Acquisition of land for drilling locations, projects, pipe-track, etc. through outright procurement as well as acquisition of ROU under P&MP Act, 1962 & providing assistance to Competent Authority for such ROU acquisition.

- c. All activities related to diversion of forestland under Forest (Conservation) Act, 1980 on behalf of User Agency i.e. OIL.
- d. Obtaining permissions for crossings of National Highway, State Highway, Railway, River, etc.
- e. Various other surveys viz. surveys for Soil Stratification, Corrosion / Soil Resistivity & Chemical Analysis, Population Density Index, etc. towards acquisition of land / ROU.

4. Service Providers' Qualification Criteria

- a. The Service Provider shall be registered under Registrar of Firms / Companies.
- b. The Service Provider shall have minimum 07 (seven) years' experience in providing assistance in land acquisition matters reckoned from the publication of this EOI.
- c. The Service Provider shall have key personnel relating to the survey and acquisition of land with all requisite qualification and experience and that of adequate numbers for carrying out multiple services / land acquisitions of minimum 03 (three) cases simultaneously.
- d. To qualify for consideration, Service Providers are required to supply 01 (one) set of the following documents –
 - i. Service Provider's organizational structure details dedicated to intended activities.
 - ii. Details of relevant verifiable experience within and outside Assam.
 - iii. Certificate of Registration.
 - iv. Undertaking certifying that the firm / company is not blacklisted by Government Department.
 - v. Permanent Account Number & GST No.
 - vi. Certified copies of turnover for last 03 (three) years.

5. The parties selected based on above criteria may be invited to give presentation-cum-discussion through video-conferencing or at Duliajan, Assam.
