CORRIGENDUM NO. 12 DATED 20.07.2020 TO E-TENDER NO. CDG3096P20
for Engineering Procurement and Construction (EPC) services for setting up
a Gas Engine Generator (GEG) based Power Plant having 3 Sets of GEGs of
capacity 10MW (approx.) each, at Duliajan Power Station, Assam’.

This Corrigendum is issued to notify the following changes:

1. Extension of dates:

- Last Date of Bid Submission extended up to **06.08.2020 (11:00 Hrs IST)**
- Last Date of Bid Opening extended up to **06.08.2020 (14:00 Hrs IST)**

2. Bidders to take note that as a very special case under the COVID -19 Pandemic situation and declaration of Lockdown by Govt. of India, in case it is not possible for them to submit the original bid bond before the Techno-Commercial bid closing date, they must upload a copy of the bid bond as part of their technical bid and also ensure that the issuing bank must route the BG through SFMS platform as per the following details:

- i) “MT 760/MT 760 COV for issuance of bank guarantee.
- ii) “MT 760/MT 767 COV for amendment of bank guarantee.

The above message/intimation shall be sent through SFMS by the BG issuing bank branch indicating the Tender No. CDG3096P20 to HDFC Bank Limited, Duliajan Branch, Utopia Complex, BOC Gate, Jayanagar, Duliajan, Dibrugarh, PIN – 786602. The Bank details are as under:

However, bidders shall have to positively upload the copy of bid bond/security deposit while submitting their bid in OIL's e-Tender portal. Bidder to confirm that they will submit the original bid bond within 10 days from the date of withdrawal of Lockdown period by Govt. of India. The non-submission of original bid bond within that period by bidder may lead to the rejection of their offer.

Otherwise, bidder can also submit the EMD amount through the e-tender portal linked Payment Gateway by using Card or Net Banking facility.
